ENGAGEMENT OF INTERN DENTAL SURGEONS 2020

- 01. The annexed list of Dental Graduates in station mentioned against their names will be engaged as Intern Dental Surgeons in the Department of Health Services with effect from 01 July 2020 to enable them to qualify for registration as Dental Surgeons in terms of the Medical Ordinance. Kindly note that six months of Oral and Maxillofacial Surgery, three months of Orthodontics and three months of Restorative Dentistry appointments need to be done.
- 02. These officers should be paid the allowance for twelve months (till 30 June 2021) as indicated in the Administration circular No.3/2016 and as approved by Cabinet Paper Dated of 01 August 2018 No.18/1412/814/027. They should be provided with accommodation free of charge where such accommodation is available.
- 03. Their internship will be terminated if their work is unsatisfactory or if there is a breech of conduct. If found unsatisfactory, they should be informed at the earliest not waiting until completion of the internship period. They will be required to abide by the regulations of the Establishments Code, the Financial Regulations, the Departmental Rules and Regulations and regulations of the Government and the orders of the Department of Health Services that may be issued from time to time.
- 04. According to the guidelines for internship of Dental Surgeons, Sri Lanka Medical Council, private practice in any form is strictly prohibited to the intern Dental Surgeons. Intern Dental Surgeons are not entitled to any paid leave. Leave is restricted to 14 days of which not more than two days should be taken at a time, except in the case of illness. If leave for more than 14 days is availed of the relevant appointment must be repeated in full unless the excess period is covered by a medical certificate and approved by the Sri Lanka Medical Council. If for any reason the period of Internship of an Intern is extended, that Intern is not entitled to any emoluments during that period.

- 05. Intern Dental Surgeons should have three white overcoats with them for use. Head of institutions are required to ensure same when they take up appointments.
- 06. They should report to the Director/Medical Superintendent of the Institution to which they are posted by 8.00 a.m. on the first day of the commencement of their Intern appointments.
- 07. Intern Dental Surgeons are entitled to obtain second class railway warrants (for the officer only) from a Medical Institution closest to him/her to travel to the station in which he/she is to serve. Such warrants will be issued on the Production of this letter.
- 08. The date of assumption of duties by these officers should be reported to this office on form Health 373.
- 09. Dental Surgeons with foreign qualifications are appointed under section 31 of the Medical Ordinance.
