Efficiency Bar Examination for Public Health Laboratory Technicians in Grade I (MT -04) belonging to the Paramedical service – 2022 (First Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by Public Health Laboratory Technicians before expiry of 05 years from the date of promotion to Grade I will be held in the media on English. The Date, Venue and the time of examination will be notified in the Admission Card.

02. Qualifications

Officers who have been appointed to a post of Public Health Laboratory Technician in Grade I and not yet completed this examination are only eligible to apply for this examination.

N.B :- Please take action to forward the applications of the officers only who have been promoted to Grade I by 31/12/2021 and have already received the appointment letters.

03. Applications

Applications prepared by the candidates as per specimen appended to this circular should be sent under registered cover to reach the Director (Examinations) "Suwasiripaya" No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before **19/08/2022** through the respective Head of Institution. The Head of Division should certify the accuracy of contents in each application. one self addressed envelopes (Candidates can write their official or private address) in the size of "9 x 4" inches, affixed with stamps to the value of Rs. 45.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.

Note: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 03 on the first side of the page and from 04 to 07 on the second side of the page. Applications which are not in compliance with the specimen form will be rejected without any notice.

04. Examination fees

- I Candidates who sit the examination for the first time need not pay examination fees. Other candidates should affix stamps to the value of Rs. 25/= in the application and cancel the same by placing his/her signature and the date.
- II The fees once paid will not be allowed to transfer for any other Examination or refunded for any reason.

05. Admission to the Examination

- I Candidates whose applications are accepted will be issued with Admission Cards. The Admission card should be duly completed and submitted same to the Supervisor at the Examination centre. Otherwise they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
- (a) National Identity Card
(b) A formal Identity Card issued formally by the Ministry of Health or relevant institutions
(c) Valid Driving License
(d) Valid Passport

06. Scheme of the Examination

This efficiency bar examination consists of a subject related question which is given 100 marks and minimum 40 marks should be obtained to pass the examination. The examination can be completed in one or several sittings.

07. Syllabus of the Examination

07.1 Subject Related Question Paper

Subject related questions paper is a three (03) hour question paper which consists of 08 essay type questions and only 05 questions should be answered. Total Marks is 100.

- i. subject fields of Malaria, Filariasis, Respiratory Diseases, Sexually Transmitted Diseases & AIDS and Leprosy.
ii. Laboratory Management

08. To follow the Regulations Related to Examination Procedure

Candidates are warned against copying or attempting to copy from the script of another candidate or from any book or paper or notes whatsoever. No candidate should attempt to look at the script of another candidate and should not help any candidate either help another candidate or obtain help from another candidate or person.
