Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries.

To date, over 132,000 officials from more than 180 countries, territories and intergovernmental organisations have participated in our courses and study visits. The SCP is managed by the Technical Cooperation Directorate of the Ministry of Foreign Affairs, Singapore.

Civil Service College (CSC)

CSC is the central learning institution for the Singapore Public Service. It plays a pivotal role in nurturing and developing people for a first-class Public Service to meet the challenges of the future. Course Objectives

In line with Singapore's constant effort to build an inclusive and caring society, this course articulates our approach to empowering persons with disabilities, and shares the multi-dimensional nature of policies in this area.

Synopsis

Topics to be covered include:

- Singapore's multi-faceted approach to empower persons with disabilities (PWDs)
- Improving the quality of life of PWDs
- Supporting caregivers, Building the community
- Building an inclusive society

Methodology

The course will be delivered for up to 30 participants through a combination of synchronous ("live" e-learning) session via Zoom, and asynchronous e-learning sessions comprising of pre-reading materials hosted on an online learning management platform.

Regulations

Participants are required to comply with the following:

- Strictly observe course schedules and not miss training sessions, and;
- Carry out instructions and abide by conditions as may be stipulated by the nominating Authority or Government and the Government of Singapore and its appointed trainer, with respect to the course.

Duration

The course will be held over **5 days** from **24 to 28 January 2022**.

The synchronous sessions will be conducted from **2.00pm to 5.30pm** (Singapore Time; UTC/GMT +8 hours) daily, with breaks when appropriate.

Application Information

Applicants should be:

- Mid- to senior-level government officials involved in social policy planning and development.
- Nominated by their respective Governments.
- Proficient in written and spoken English.
- Able to attend the course daily from 2.00pm to 5.30pm (Singapore Time, UTC/GMT +8)

Terms of Award

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.

Application Procedure

(Closing date for nomination: **27 December 2021**)

The Government of Singapore is pleased to invite the respective National Focal Point for Technical Assistance (NFP) to nominate **one (1)** suitable applicants. Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective NFP in the event that its nominee(s) is not selected.
