General Circular Letter No. 02 - 87 / 2015 (3)

Recruitment for Post-Basic Nursing Training – 2015

General Circular No.02/87/2015 (1) dated 29.09.2015 and General Circular No.02/87/2015 (2) dated 10.10.2015 issued making amendments to the Circular No.02/87/2015 dated 17.09.2015 titled “Recruitment for Post-Basic Nursing Training -2015” and the sections thereof, are amended as follows by the order of Public Service Commission.

02. The qualification “Should have shown a higher performance than the satisfactory level within one (01) year immediately prior to the date of promotion in terms of approved procedure of performance appraisal ” given under the sub- section 03 regarding qualifications required to be satisfied by applicants under the section 03 (Qualifications) of General Circular No. 02-87/2015 dated 17.09.2015, is hereby removed as applicable to this recruitment only.

03. Even if the qualification mentioned under 3.3 of the Circular No 02/87/2015 dated 17.09.2015 has/has not been satisfied, officers in the Nursing Service who have already submitted applications are not required to re-apply in terms of this amended circular. Action is taken considering the applications submitted by them, have been submitted under the provisions of this circular.

04. Officers who have satisfied qualifications as at 31.10.2015 in terms of this amended circular, are only eligible to apply.

05. Officers who apply in terms of this circular should submit their applications to the respective Head of Institute on or before 13.01.2017. Heads of Institutions should recommend and send the applications to reach the following address on or before 18.01.2017.

06. And, other provisions given in the circular No. 02-87/2015 dated 17.09.2015, General Circular No. 02-87/2015(1) dated 29.09.2015 which was issued making amendments to the sections thereof and General Circular No. 02-87/2015 (2) dated 10.10.2015 will prevail unchanged.

07. In the event of any inconsistency between the Sinhala, Tamil and English texts of this circular, the Sinhala text shall prevail.
