- **01.** The draft list of Dental Surgeons noted for annual transfers 2020 is attached. (Annexure 01)
- 02. Noted list: The criteria for Dental Surgeons to be noted for the 2020 annual transfer is,
 - **A.** Dental Surgeons who were assigned posts from Annual Transfer and completing 04 years or more at the station by 31.12.2019, based on the effective date of the transfer order.
 - **B.** Dental Surgeons who were assigned special posts from Annual Transfer and completing 02 years or more at the present station by 31.12.2019, based on the effective date of the transfer order.
 - C. Newly appointed Dental Surgeons who complete 04 years or more at the station by 31.12.2019, based on the effective date of the transfer order.
 - **D.** Newly appointed Dental Surgeons who were assigned Special Posts and completing 02 years or more at the station by 31.12.2019, based on the effective date of the transfer order.
 - **E.** Dental Surgeons who are currently temporarily attached after foreign leave, after PGIM studies and after Secondment Posts.
 - **F.** Dental Surgeons who were assigned 1 year posts in 2019 annual transfer.
 - **G.** Dental Surgeons who were reinstated in 2016.

Officers who have not reported to a previous transfer order will be excluded except those who received 1 year posts.

03. Criteria to include in the Eligible list for Transfers & Officers Considered as Not Noted (CNN):

A web based consent form has been developed to request to include in the Eligible List / to remain in the same station (CNN) and to submit any other claims. All Dental Surgeons are kindly informed to submit their requests only through web based consent form in the official web site of Ministry of Health, Nutrition & Indigenous Medicine (health.gov.lk – staff access>admin>transfers click the link in application form tab) and send the printed copy of the same, duly endorsed by the Head of the institutions / Heads of Decentralized Units with documentary proof (Grade letter, confirmation letter, reporting letter) on or before 27.09.2019. You are kindly requested to fax the same (with the endorsement of the Head of the institution) to Director, Dental Services office on 0112692846 to expedite the transfer process.

Please note -

Those who do not submit their requests to become eligible on or before 27.09.2019 will not be considered for transfers either at the initial stage or at the appeal stage level.

Requests to become CNN will only be accepted before 27.09.2019

All officers who have completed 02 years or more in their present station by 31.12.2019 based on the effective date of the transfer order are eligible to apply for annual transfers 2020. Officers who become eligible will be awarded posts only by their preferences. If their preferences are not available they will be allowed to remain in their same station. However if an eligible officer is assigned a post they applied for, they will not be allowed to appeal to remain at their current station.

All heads of institution are required to verify grade dates, nopay and probation details of applicants before forwarding the applications.
