<u>Annual Transfers of Dental Surgeons 2020</u> <u>Recommendations for Annual Transfer of Dental Surgeons- 2020 (Stage II)</u>

This refers to the even numbered letters published on the official web site of the Ministry of Health, Nutrition and Indigenous Medicine on 19.09.2019, 23.10. 2019, 02.12.2019, 08.01.2020, 13.02.2020 and 20.02.2020 with regard to Annual Transfers of Dental Surgeons 2020.

- 1) List of Dental Surgeons recommended for Annual Transfers 2020 Stage II is published here with. This list has been prepared based on the applications forwared by surgeons, with the concensus of majority of the members of transfer board. Despite the invitation sent by Ministry of Health to participate in the transfer board, nominee of the Government Dental Surgeons Association did not take part. Please consider this as a notice of information, calling for appeals. Heads of the Institutions are advised not to release these officers till the final transfer order is made by the Health Services Committee of Public Service Commission.
- These recommendations are based on criteria approved by Public Service Commission by the letter dated 07/11/2017.
- Applications have been considered to transfers only from Dental Surgeons noted for transfers or those who requested to include their names in eligible list and applied for Stage II as per the even numbered letters dated 19.09.2019 and 13.02.2020.
- 4) The stations marked with NEP (Not Enough Preferences) are assigned, at the discretion of transfer board due to not enough preferences in their applications. If a qualified Dental Surgeon wishes to apply for any of the stations falling vacant can do so before the closing date for consideration by the appeal board.

- 5) Dental Surgeons who wish to get any station marked with NEP can forward an appeal to any such station. Hence Dental Surgeons whose stations marked with NEP must appeal with a list of preferences to get a permanent station in the appeal stage or their allocated station as NEP will be reassigned to any applicant who requests for it in Appeal stage. Applicants with NEP who do not appeal or have NEP again in appeal stage will be assigned a station from what is left over at end of Appeal stage.
- 6) List of vacancies for appeal stage is the same as Stage 2. All noted or additional vacancies not filled in Stage 2 recommendation list are definite vacancies in Stage 2 Appeal. All vacancies filled or 'regrets' in Stage 2 are potential vacancies in appeal stage provided that the recipient is reassigned to a different station in the appeal stage. Hence applicants are requested to consider all definite and potential vacancies when applying in the appeal stage. The preferences given in recommendation stage original applications will be not be considered.
- 7) The officers not noted for transfer but eligible were marked as "regrets" when the requested stations were not available at their seniority positions. They may appeal for vacant or potentially vacant stations, if they wish to get a transfer. Please note that their original application will not be taken in to consideration at appeal stage.
- 8) All appeals against any of these recommendations must be submitted online first and then send the hard copy duly signed to the below mentioned address. Hard copy will be used for authentication purposes. The preferences will be considered only based on online application and not from the hard copy.
- 9) Appeals will be considered only from those Dental Surgeons who applied for transfers as per even numbered letter dated 13.02.2020.
- 10) Appeals should be made to the Director General of Health Services on or before **21**.06.2020 and sent to reach the following address.

- 11) Appeal board will pay due attention to such appeals and Secretary Health, Nutrition and Nutrition and Indigenous Medicine will announce the final approved transfer list once the Public Services Commission approval is obtained.
