**Approved and Rejected Requests for Re-attachments in Annual Transfer Implementation - 2021**

This is further to the letters of re-attachments of Medical Officers and MA/MS/B/01/2020 and dated 14.12.2020 and MA/MS/B/03/2019(A) and dated 12-01-2021. (The letters are attached).

Please note that all the previously approved re- attachments were cancelled with effect from 31<sup>st</sup> December 2020 and a new reattachment list was published as per MA/MS/B/03/2019(A) and dated 12-01-2021.

On the further requests of Heads of Institutions, attached list of Medical Officers are approved for reattachment until 31<sup>st</sup> March 2021 with effective from 01<sup>st</sup> January 2021. This will be in addition to the reattachment list published on 12-01-2021, considering the service exigencies.

Please be kind enough to note that,

1. If a Medical Officer is already released from the Institution, but appears in this reattachment list, will not be entitled to transfer back to their previous station, despite being given a reattachment.
2. Despite given the reattachment, if suitable replacement is available or arranged, any Medical Officer can be released to their transferring station.
3. Personal skeleton files and salary particulars of all Medical Officers who are on transfer orders must be sent to their transferred stations with immediate effect.
4. Their salary must be paid upon reception of personal skeleton file and salary particulars, by the newly transferred station.
5. The physical presence of re-attached Medical Officers to their new stations are not required, due to ongoing COVID - 19 outbreak.
6. All the Medical Officers who are on transfer orders on or before 2019, without any approved reattachments must be released to the newly transferred station as soon as possible, as you are liable for audit queries for paying the salaries for such Medical Officers without the approval of the Secretary Health.
7. Further reattachments, beyond 31<sup>st</sup> March 2021, will ONLY be given to those Medical Officers, without replacements
8. Any requests for further such reattachments must ONLY be submitted through following link [shorturl.at/mrAXY](http://shorturl.at/mrAXY), on or before 6<sup>th</sup> April 2021.
