**Replacement List for Specialist Medical Officers Annual Transfers – 2020**

The attached is a list of Acting Consultants of each specialty and the stations available for them to apply.

01. The following categories of medical officers are eligible to apply.
  - a. Specialist Medical Officers who are holding temporary appointments and are Board Certified from PGIM.
  - b. Senior Registrars after foreign training who are holding temporary appointments and are not yet Board Certified.
  - c. Senior Registrars who have completed their local training.
02. It is compulsory for the officers belonging to 01. a/ b/ c categories to apply for this replacement list even if their names have not appeared in the list.
03. All applicants who are Board Certified as specialists by **31.05.2020** are requested to submit a copy of board certification letter issued by the Director PGIM along with the application.
04. It is the responsibility of the applicant to provide correct data in order to maintain the accuracy. If incorrect data is provided by an officer, serious disciplinary action could be taken against the said officer according to provisions of the E- Code.

05. Officers, who do not forward their applications indicating their choices, will be appointed to stations by the Transfer Board which are vacant at the discretion of the Transfer Board.
06. Heads of Institutions are responsible to bring the contents of this circular to the notice of all eligible applicants who are currently holding acting appointments temporarily, in their institutions and forward the applications to the department as indicated below.
07. The list of vacancies may be amended (posts added or deleted) subject to exigencies of service. Therefore applicants are advised to mark adequate choices in the applications.
08. **This list is published to invite observations regarding the draft. Suggestions and Observations should be submitted through the Ministry of Health website ([email: dtes.moh@gmail.com](mailto:dtes.moh@gmail.com)) on or before 27/06/2020, 9.00 a.m**
09. All eligible applicants are hereby requested to send in their applications via online. The online application is available at [medserv.health.gov.lk](http://medserv.health.gov.lk). the online system will be ready for application form **29.06.2020** onwards till **04.06.2020** date.
10. If you encounter any issues in applying to your specialty/subspecialty it is your duty to inform Director (Tertiary Care Services) immediately by fax & email.
11. Considering of the facts that the prevailing COVID- 19 pandemic situation, possible delay in activation of Annual Transfer 2020 due to technical difficulties and categorization of applicants, Ministry of Health shall accommodate all applicants to a common list and also request all to apply at the earliest to efficiently activate the Annual Transfer 2020.
